SUBJECT: NRC INSPECTION REPORT NOS. 50-250/90-25 AND 50-251/90-25

This refers to the Nuclear Regulatory Commission (NRC) inspection conducted by R. C. Butcher on June 30, 1990 through August 3, 1990. The inspection included a review of activities authorized for your Turkey Point facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.
