SUBJECT: RIVER BEND STATION, UNIT 1 LICENSE RENEWAL APPLICATION REVIEW
DECEMBER 2017 STATUS LETTER (CAC NOS. MF9747 AND MF9778)

Dear Mr. Maguire:

By letter dated May 25, 2017 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML17153A282), the U.S. Nuclear Regulatory Commission (NRC or the staff) received the Entergy Operations, Inc. (Entergy) application for renewal of Operating License NPF-47 for River Bend Station, Unit 1 (RBS). The application was supplemented by letter dated August 1, 2017 (ADAMS Accession No. ML17213A064, Non-Public). On August 7, 2017 (ADAMS Accession No. ML17177A058), the application was accepted for review. The purpose of this letter is to provide the status of the license renewal application review for RBS.

For the safety review, the operating experience, scoping and screening, in office (at NRC headquarters) aging management program (AMP), and on site (at RBS) AMP review audits were completed as scheduled on October 13, 26, November 3, and 8, 2017, respectively. Entergy's CERTREC document portal is still operational and all document requests have been completed. The staff is about one month into the next major phase of its review, which is the issuance of requests for additional information (RAI). To date the staff has issued RAI sets 1 through 6, via RAI letters to Entergy, for a total of 30 RAIs. Entergy has submitted responses to the first two RAI sets. The staff is in the process of reviewing the responses, issuing the remaining RAIs, and drafting the Safety Evaluation Report.

For the environmental review, the environmental and severe accident mitigation alternatives (SAMA) audits were completed on October 26, 2017. The staff issued environmental RAIs on November 7, 2017 and received the RBS response on December 11, 2017. The staff issued SAMA RAIs on November 8, 2017, and received the RBS response on December 5, 2017. The staff is in the process of reviewing the responses and drafting the Environmental Impact Statement.

This letter also updates the enclosed safety and environmental review schedule for the RBS application. At this time the review is on schedule.
