The U.S. Nuclear Regulatory Commission (NRC) staff prepared a draft topical report safety evaluation in support of Westinghouse Electric Company's (WEC) submittal of WCAP-17938, "AP1000 In-Containment Cables and Non-Metallic Insulation Debris Integrated Assessment," Revision 2, dated June 7, 2017 (Agencywide Documents Access and Management System Accession No. ML17163A296).

The staff's draft topical report safety evaluation for WCAP-17938, Revision 2, is being provided to the Advisory Committee on Reactor Safeguards Subcommittee for information only.

The enclosed draft topical report safety evaluation is being provided only to Westinghouse for review of proprietary information pursuant to Title 10 of the *Code of Federal Regulations* 10 CFR 2.390 "Public Inspections, Exemptions, Requests for Withholding." The NRC will withhold the enclosed draft topical report safety evaluation from public disclosure for a total of 20 business days. This includes 10 business days from the date of this letter to allow you the opportunity to identify proprietary content and security-related information in the staff's draft topical report safety evaluation that is not already identified and 10 business days for a check of any factual errors. If within that 20-day period you do not request that all or portions of the draft topical report safety evaluation be withheld from public disclosure, the enclosure will be made publicly available through the NRC Public Documents Room and the Publicly Available Records component of the NRC Agencywide Documents Access and Management System.
