SUBJECT: TURKEY POINT REQUALIFICATION EXAMINATION REPORT NO. 50-250/92-300

During the period February 24 through March 6 1992, the NRC administered requalification examinations led by Richard S. Baldwin to employees of your company who currently hold licenses to operate the Turkey Point Nuclear Plant. At the conclusion of the examination, the examination questions and preliminary findings were discussed with those members of your staff identified in the Examination Report, Enclosure 1.

A copy of the written examination questions and answer keys is included in this report as Enclosure 2. A Requalification Program Evaluation Report is included as Enclosure 3. The evaluation report finds that the Turkey Point requalification program is classified as satisfactory. A Simulator Fidelity Report is provided as Enclosure 4.

Even though the proposed simulator scenarios met or were modified to meet the Examiner Standards (ES); 604-1, "Simulator Review Checklist," the NRC is concerned with the content of the evaluation scenarios. Details of this concern can be found in Enclosure 2, paragraph 1.b.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosures will be placed in the NRC Public Document Room.
