SUBJECT: NRC INSPECTION REPORT NOS. 50-250/93-17 and 50-251/93-17

This refers to the inspection conducted by Mr. R. C. Butcher of this office on May 29 through June 25, 1993. The inspection included a review of activities authorized for your Turkey Point facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed Inspection Report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The enclosed Inspection Report identifies activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B of the Enforcement Policy. Therefore, a response is not required.
