This letter is in regard to your amendment requests dated August 14, 2017 and August 16, 2017, requesting a name change for your exempt distribution license, 20-23904-01E, and Sealed Source and Device (SSD) Registration Certificate NR-0399-D-101-E. After reviewing your amendment requests, the U.S. Nuclear Regulatory Commission (NRC) staff sent you a letter dated October 26, 2017, requesting additional information. As of the date of this letter, the NRC has not received a complete response to the request for additional information.

Due to incomplete information, the NRC staff is unable to complete an evaluation of your amendment requests. Therefore, the NRC staff has discontinued the evaluation of your amendment requests (SSD Case No. 17-39, and License Action Mail Control No. 600443). This action is taken without prejudice to submission of the requested information. Please note that when you resubmit your application at a later date, you may refer to Mail Control No. 600443 and SSD Case No. 17-39 for the documentation you have already submitted.
