On May 9, 1994, the NRC documented its review of the information provided in response to Generic Letter (GL) 92-01, Revision 1, "Reactor Vessel Structural Integrity," for the Turkey Point Units 3 and 4 reactor vessels. The NRC requested that Florida Power & Light Company (FPL) verify the accuracy of the pressurized thermal shock and upper shelf energy summary file information for Turkey Point Units 3 and 4, listed in Enclosures 1 and 2 of the May 9, 1994 NRC letter. By letter L-94-134 dated June 6, 1994, FPL informed the NRC that verification of the Turkey Point Units 3 and 4 summary file information would be provided by the Babcock & Wilcox Owners Group (B&WOG).

The purpose of this letter is to endorse, for applicability to Turkey Point Units 3 and 4, the B&WOG report BAW-2222, "Reactor Vessel Working Group Response To Closure Letters To NRC Generic Letter 92-01, Revision 1," submitted by B&WOG letter OG-94-1393 dated June 23, 1994, (J. H. Taylor to USNRC).
