We recently received information concerning activities at Turkey Point. The details are enclosed for your review and follow-up.

We request that the results of your review and disposition of these matters be submitted to us within 45 days of the date of receipt of this letter. We request that your response contain no personal privacy, proprietary, or safeguards information so it can be released to the public and placed in the NRC Public Document Room. If necessary, such information shall be contained in a separate attachment which will be withheld from public disclosure. The affidavit required by 10 CFR 2.790(b) must accompany your response if proprietary information is included.

The enclosure to this letter should be controlled and distribution limited to personnel with a "need to know" until your investigation of the concern has been completed and reviewed by us. The enclosure to this letter is considered exempt from Public Disclosure in accordance with Title 10, Code of Federal Regulations, Part 2.790(a)(6) and (7). However, a copy of this letter excluding the enclosure will be placed in the NRC Public Document room.
