The purpose of this letter is to notify you that we have completed our self-assessment of the SPEAKOUT program (i.e., have a report which identifies various improvement opportunities) and have concluded that we continue to maintain an effective program.

The NRC, Region II, conducted an Employee Concerns Program inspection during the same time that the self-assessment was being performed. Recommendations from FPL's self-assessment and the NRC's Inspection Reports, 50-250/50-251/96-05 and 50-335/50-389/96-07 dated May 31, 1996, are being reviewed by senior management to determine appropriate program enhancements.
