The U.S. Nuclear Regulatory Commission has approved the enclosed exemption from specific requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Paragraph 70.22(i)(3)(xii) for the American Centrifuge Lead Cascade Facility. This action is in response to your letter dated August 22, 2017, which requested an exemption to reschedule the biennial onsite emergency preparedness exercise from calendar year (CY) 2017 to the third quarter of CY 2018. Accordingly, a one-time exemption from 10 CFR 70.22(i)(3)(xii) has been granted for the rescheduling of the exercise to the third quarter of CY 2018.

A copy of the exemption has been forwarded to the Office of the Federal Register for publication.
