Dear Chairman Flying Hawk:

The U.S. Nuclear Regulatory Commission (NRC) staff is reviewing a request for an amendment to Source Materials License SUA-1534 that would authorize Crow Butte Resources, Inc. (the licensee) to construct and operate an in-situ uranium recovery satellite facility at the proposed Marsland Expansion Area in Dawes County, Nebraska.

Pursuant to the National Environmental Policy Act, the NRC staff has prepared a draft Environmental Assessment (EA) to document its environmental review of the amendment request. The draft EA includes a description of the proposed action and the affected environment, along with the NRC staff's preliminary determinations regarding the potential environmental impacts should the license amendment be granted.
