

#### REPORT MONTH October 1998

Unit 3 was shut down for a refueling outage for most of October. The unit's return to power operations was delayed by about 70 hours by Hurricane Georges (see LER 250/98-005). The unit was restarted on October 27, and placed on line on October 28. Early on October 29, the unit was taken back off line to perform a turbine overspeed test, and placed back on line later that day. Power was slowly increased, and finished the month at approximately 49% reactor power.
