This refers to your license amendment request dated September 28, 2017. Please find enclosed Amendment No. 24 authorizing Sara J. Meehan as the Radiation Safety Officer and updating your Operational and Emergency Procedures. Additionally, the license was changed to the new format and more specifics were placed on similar sources and devices.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
