ORDER

On November 24, 2017, the NRC provided notice in the *Federal Register* of AREVA Inc.'s applications for license amendments to an existing import license (IW009) and an existing export license (XW1015).¹ In accordance with 10 C.F.R. § 110.82(c), the *Federal Register* notice set a deadline of December 26, 2017, for members of the public to file a request for a hearing and petition for leave to intervene on AREVA Inc.'s applications.

On December 19, 2017, Nuclear Information and Resource Service (NIRS) and Oregon & Washington Physicians for Social Responsibility requested a 30-day extension of time to file hearing petitions on AREVA Inc.'s applications to allow additional "time to review and fully understand the docket and the applications."²

I have reviewed the extension request, but find no basis for granting a 30-day extension of time to file hearing petitions. Accordingly, I deny this request. However, I set a new deadline three business days from the date of this order for NIRS and Oregon & Washington Physicians for Social Responsibility to submit hearing petitions.

This Order is issued under my authority in 10 C.F.R. § 110.88.
