License Amendment Request TSCR-166, Adoption of Emergency Action Level Scheme Pursuant to NEI 99-01, Revision 6, "Development of Emergency Action Levels for Non-Passive Reactors"

In accordance with 10 CFR 50.90, NextEra Energy Duane Arnold, LLC, (NextEra) hereby requests an amendment to the Duane Arnold Energy Center (DAEC) Emergency Plan. The proposed change involves revising the Emergency Plan for DAEC to adopt the Nuclear Energy Institute's (NEI's) revised Emergency Action Level (EAL) scheme described in NEI 99-01, Revision 6, "Development of Emergency Action Levels for Non-Passive Reactors," which has been endorsed by the NRC.

10 CFR 50, Appendix E, Section IV.B.2 stipulates that a licensee desiring to change its entire EAL scheme shall submit an application for an amendment to its license and receive NRC approval before implementing the change.
