SUBJECT: SUMMARY OF MARCH 8, 2017, CLOSED MEETING WITH
AREVA INC. REGARDING ENHANCED ACCIDENT TOLERANT
FUEL

On March 8, 2017, a closed meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff and AREVA Inc. (AREVA). During the meeting, AREVA informed the NRC staff of the development and plans for enhanced accident tolerant fuel (EATF). AREVA discussed the goals of the EATF program, its approach, and the concepts of fuel types that fit in the near term plan and the long term plan. The NRC staff provided feedback to AREVA on what was discussed.
