I am sorry that the Disabled People whom you represent are unwilling to meet with representatives of the N. C. Division of Emergency Management and Carolina Power & Light Company to discuss your concerns about the Shearon Harris Plant.

You will recall that we agreed to meet, and also to your conditions that the meeting be held in a public place at a time convenient to you; that the media be invited to attend and report on the meeting; that you videotape the meeting; and that each party designate a spokesperson. We remain willing to meet under these and any other reasonable conditions you suggest.

Carolina Power & Light Company and the State's Division of Emergency Management are committed to the protection of the health and safety of the public around the Harris Plant. Both CP&L and DEM are also dedicated to the education of the public about emergency plans in support of the plant and to addressing any concerns of the public about the adequacy of these plans. CP&L and DEM have always been responsive to questions and concerns about the emergency plans and responsive to suggestions of ways to better these plans.

We sincerely care if you have concerns about the emergency plans. We would welcome an opportunity to discuss them with you. Should you change your mind and be willing to meet with us please call me at 836-6189. I understand that officials from the State Division of Emergency Management also remain willing to meet with you.
