Also, as I was reviewing your public and non-public license applications, I noticed that you requested to redact the Countries of Ultimate Destinations on the application and on the export license.

After consulting with the Office of the General Counsel (OGC) and Stephen Baker, we have determined that the Countries of Ultimate Destinations must be released to the public.

To sign the form 7 using a digital signature in pdf, below are the steps:

1. Open and fill out the NRC form 7
2. Go to page 3
3. In the top right of the form 7, select Fill & Sign
4. Select Place Signature
5. Click, Drag New Signature Rectangle....
6. Drag the rectangle on page 2 of where you will need to sign the form 7
7. You will have several options to select for your signature, select one of those options
8. Once you have created your signature, the pdf will then prompt you to where it should be filed
9. Email me the form 7
