As a result of the Reactor Coolant System (RCS) Loop Piping inspections performed at SHNPP during the week of August 22, 1988, CP&L was requested to submit additional information concerning the RCS Loop Piping. Enclosed in the copy of this submittal sent to Mr. Mark M. Holtzman is the requested material. This information consists of:

1. Westinghouse Equipment Specification G-678866 Rev. 2 dated October 24, 1973 "Reactor Coolant Seamless Forged Pipe to ASME III, Class 1, Safety Class 1." (PROPRIETARY)
2. Westinghouse Equipment Specification G-678865 Rev. 0 dated November 21, 1971 "Reactor Coolant Cast Fitting ASME III, Class 1." (PROPRIETARY)
