1. Revised Appendix C, Safeguards Contingency Plan, Section 7 “Protective Strategy,” Page C-34 and C-35 to support the Fermi 2 Protective Strategy change and description.
 - a. Deleted the following sentence in paragraph 3 of Page C-35: “The one exception is a section on the south west side of the PA of approximately sixty feet; where there is sufficient distance coupled with an additional delay fence within the PA to allow ARs to effectively thwart potential attacks.”
2. Revised Figures 1-3, 1-3a and 1-3b; removed one BRE (Bullet Resistant Enclosure) and added one BRE (to support the relocation of an Armed Responder position) to the figures.
