Gentlemen:

On April 2, 1992, Carolina Power & Light Company (CP&L) submitted a request to revise the Technical Specifications (TS) for the Shearon Harris Nuclear Power Plant (SHNPP). The proposed amendment requested revisions to Instrumentation Specifications 3.3.2, 3.3.3.1, and 3.3.3.6.

Subsequently, your staff requested that CP&L make some changes of an editorial nature to the proposed TS pages submitted on April 2, 1992. The requested changes were incorporated into revised TS pages and submitted on October 14, 1992. Your staff has again requested that CP&L make additional editorial changes to the proposed TS pages submitted on April 2, 1992. Enclosed are revised marked-up and retyped pages which incorporate the changes per the second request. The addition of these editorial changes has no impact on the significant hazards consideration contained in the April 2, 1992 submittal.

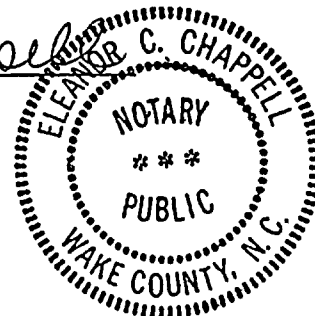
