NRC REQUEST FOR ADDITIONAL INFORMATION REGARDING THE SHEARON
HARRIS INDIVIDUAL PLANT EXAMINATION (IPE) SUBMITTAL

Gentlemen:

By letter dated October 12, 1994, the NRC requested that CP&L provide additional information related to the Individual Plant Examination (IPE) for the Shearon Harris Nuclear Power Plant. That letter requested that the additional information be provided within 60 days of receipt of the letter. Because of the extensive nature of the request, CP&L discussed with the NRR Project Manager the need for additional time to properly address the request and respond. On October 27, 1994, the NRR Project Manager informed CP&L that an extension of 30 days would be acceptable to the NRC staff. In accordance with that discussion, the purpose of this letter is to confirm that CP&L plans to submit the requested additional information by January 16, 1994.
