

Gentlemen:

The purpose of this letter is to notify the NRC of CP&L's intention to convert the current Technical Specifications (TS) for the Harris Nuclear Plant to the Improved Standard TS using NUREG-1431, Standard Technical Specifications, Westinghouse Plants. The Harris Nuclear Plant's current TS were developed from NUREG-0452, draft Revision 5. In conjunction with this conversion process, CP&L is participating in the Westinghouse Owners Group MERITS Mini-Group effort.

We currently plan to submit a license amendment to the NRC by December 1996, with a request for NRC license amendment issuance by June 1997. This schedule will support implementation later in 1997.

CP&L will ensure that the NRC Project Manager is kept informed of the progress of the Harris Nuclear Plant conversion program. We would be pleased to provide any additional information necessary to facilitate the NRC's planning for this effort.
