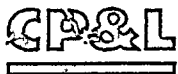

SUPPLEMENT TO A REPLY TO NOTICE OF VIOLATION
(NRC INSPECTION REPORT NO. 50-400/96-06)

Dear Sir or Madam:

On October 7, 1996, Carolina Power & Light (CP&L) responded to the Notice of Violation enclosed in NRC Inspection Report 50-400/96-06 dated September 6, 1996. The purpose of this letter is to supplement our reply to the Reported Violations "A" and "B". Specifically, under Corrective Steps That Will Be Taken to Avoid Further Violations, CP&L's reply stated in part the following:

"The ongoing FSAR Improvement Plan review to identify other discrepancies will be completed. Specifically, the initial FSAR review will be completed by September 1, 1997. In addition, two "vertical slice" FSAR system reviews will be completed, (Reactor Protection System in 1996 and Fire Protection in 1997)."

CP&L has completed the Reactor Protection System review as stated in our previous reply. In lieu of performing the review of Fire Protection in 1997, a review will be performed for the Auxiliary Feedwater System in 1997. Therefore, CP&L wishes to revise the above stated paragraph to read as follows:

"The ongoing FSAR Improvement Plan review to identify other discrepancies will be completed. Specifically, the initial FSAR review will be completed by September 1, 1997. In addition, a "vertical slice" FSAR system review of the Reactor Protection System was completed December 27, 1996 and a similar review of the Auxiliary Feedwater System is planned for 1997."
