During the six weeks covered by this inspection period, our inspectors found that your staff generally took a safety-conscious approach to the operation of the facility.



Based on the results of the inspection, the NRC has determined that a violation of NRC requirements occurred. The violation is cited in the enclosed Notice of Violation, and the circumstances surrounding the violation are described in detail in the enclosed report.

The NRC has concluded that information regarding the reasons for the violation, the corrective actions taken and planned to correct the violation and to prevent recurrence, are addressed on the docket in the enclosed inspection report. Therefore, you are not required to respond to this letter unless the description therein does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.

During the inspection period, the NRC received a response dated November 23, 1998, to Notice of Violation 50-400/98-08-03 and to a requested response regarding your corporate office consistently adhering to applicable regulatory requirements. Regarding the violation, we have evaluated your response and found that it meets the requirements of 10 CFR 2.201. Based on discussions between Mr. C. VanDenburgh of your staff and the Shearon Harris Senior Resident Inspector, Mr. J. Brady, it is our understanding that the corporate support actions described in your response and delineated in your meeting handouts from the November 19, 1998, meeting in the Region II Office in Atlanta, Georgia, are scheduled to be completed by January 1, 1999. We understand that an effectiveness review of these changes is scheduled to be completed by March 31, 1999. We will examine the implementation of these actions during future inspections.
