over 20 years and have followed the issue of depleted uranium at PTA since 2009 when Colonel Howard Killian, U.S. Army Installation Management Command, asked me to prepare a white paper on DU at PTA. That paper is included in the NRC Adams Library at ML092940675, having been submitted to the library by Mr. John Hayes.

There are several points on this particular issue for which I believe need thorough and specialized insight that I can provide. Revising the scales of overlapping maps often has additional consequences. In this case, these include information on proposed siting as well as proper sampling methodologies and analysis, the geologic lay-of-the-land, its impact on a sampling program, and consideration of proximity to the cantonment area, the nearby Girl Scout Camp, and the Mauna Kea County Park.

I trust that you will accept my offer and recognize that it can provide you focused assessment that may not be readily available from in-house expertise to evaluate this very multidimensional topic.
