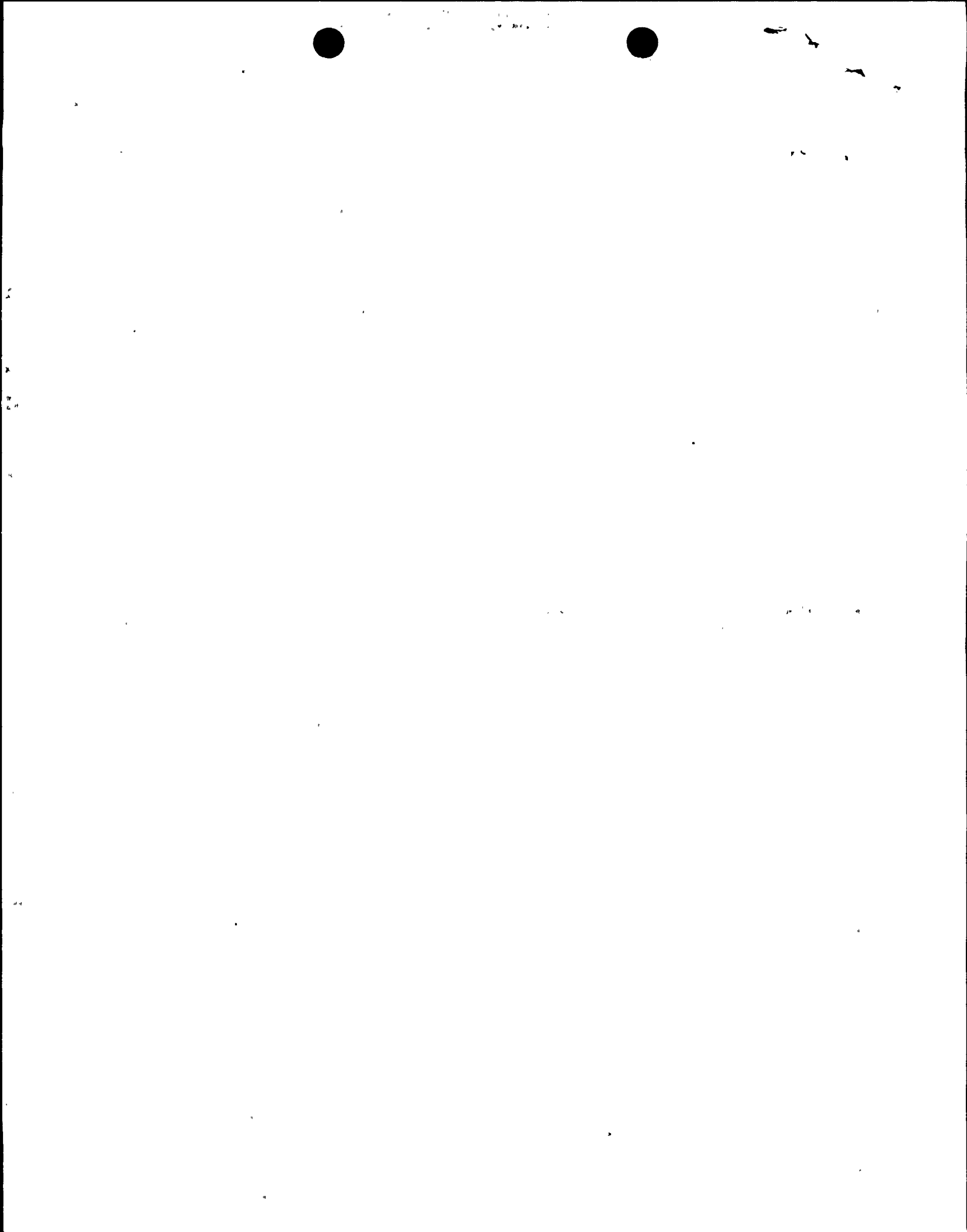

In accordance with 10 CFR 50.74(a), Carolina Power & Light Company (CP&L) provides notification that three Senior Reactor Operators licensed on the Harris Nuclear Plant have been reassigned from the position for which CP&L previously certified the need for a senior reactor operator license.
