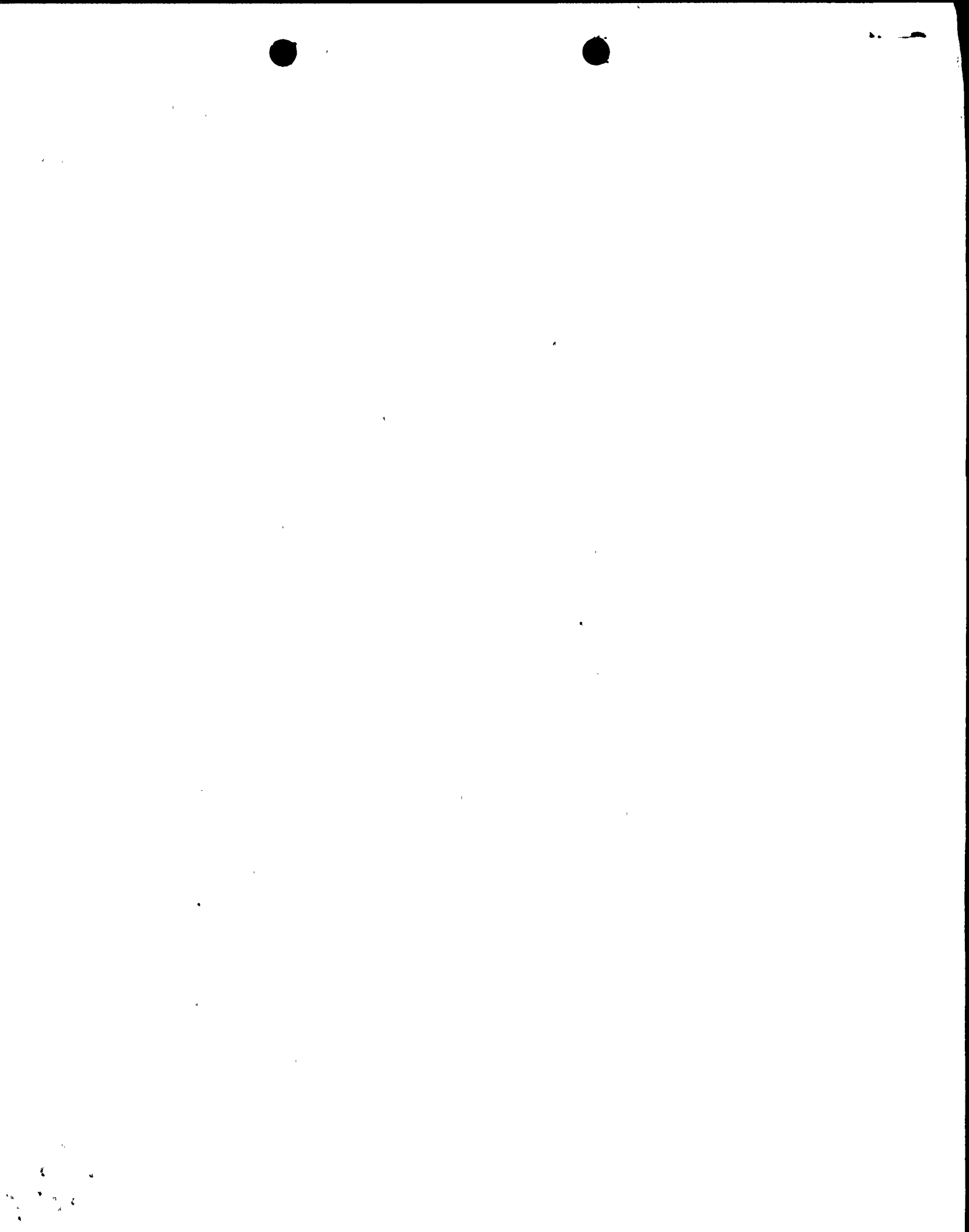

Twenty (20) copies of the subject letter report are being provided by General Electric Company on behalf of the Mark II Owners Group for information as part of the Mark II Containment Supporting Program, Task A.16. This letter report provides the results of a comparison of the Mark II containment response to the lead plant 4T Bounding Loads Report chugging load specification with that for an improved load specification based on an impulse chug source at the vent. This comparison was done for a pre-stress concrete, reinforced concrete, and steel containment to show that the 4T bounding load specification is conservative and suitable for lead plant application. In addition, this study introduces aspects of improvement in this load definition for consideration in subsequent plant evaluations.


