The Nine Mile Point Nuclear Station Unit #1 Environmental Technical Specifications Section 3.2.d references the requirement for written notification to the Commission in the event that milk samples are no longer available from a previously sampled location. In compliance with these requirements, the following is submitted:

In contacting the farmers where milk samples had been collected in previous seasons in preparation for the 1978 seasons, we were informed by one farmer that he would not sell us milk samples this year.

A new location will be substituted so that milk is sampled at four locations as required by the Environmental Technical Specifications.
