Dear Mr. Holland:

This refers to your license amendment request dated October 31, 2017. Please find enclosed Amendment No. 9 removing Dr. Cuscela as requested. In addition, the use of licensed material under 10 CFR 35.300 was limited to Iodine-131, with the removal of Dr. Cuscela, consistent with the training and experience of your remaining authorized users involved with therapy treatments. This change was discussed with your consultant, Mr. Jeannette, and he confirmed that you only use iodine-131 for therapies at this time.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC. This could include issuance of a Notice of Violation, or Imposition of a Civil Penalty, or an Order Suspending, Modifying or Revoking Your License as specified in the NRC Enforcement Policy.
