I, S. R. Zimmerman, having been first duly sworn, hereby depose and say as follows:

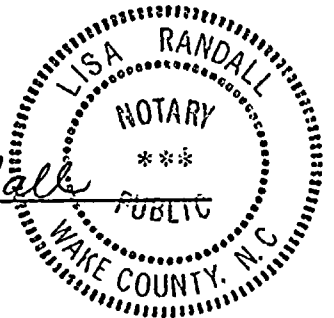
