I, S. D. Floyd, having been first duly sworn, hereby depose and say as follows:

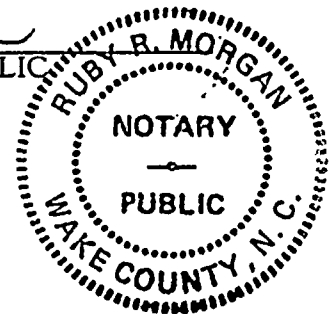

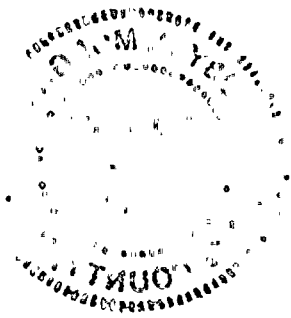
