On January 4, 2018, the US Nuclear Regulatory Commission (NRC) issued the Security Inspection Report for the Vogtle Electric Generating Plant Units, ADAMS Accession Number ML18004A310. (non-public version) In reviewing this report, we identified an administrative error regarding the Report Number.
