Dear Mr. Denton,

I had a couple of questions for you and your staff regarding the status of various matters before you in the Harris case:

- 1.) Where is the draft copy of the Shearon Harris operating license that I requested in a letter to you after our meeting over a month ago? You never answered my letter. Does this mean you are refusing to give us a copy of this document or is it still being processed? Please update us and let us know when it will be available.
- 2.) What is the status of the FOIA request which we filed with your office at the beginning of August in support of our July 9, 1986 2.206 petition? Is this request being processed and when can we expect a response?
- 3.) Will you send us a copy of CP&L's response to the violations which were noted in inspection report #50-400/85-48 concerning the improper pre-service inspection procedures, which were also discussed at length in our July 9 2.206 request? We were pleased that Region II has begun to look into some of the allegations that are being made by CASH and Ms. Miriello and expect that a much more extensive investigation will be launched into the improper documentation of welds on safety-related equipment at the Harris reactor. Please let us know about the status of this investigation.
- 4.) What is the current status of CP&L's exemption request from the requirement for a full participation evacuation/emergency preparedness exercise? I know they asked for a decision by August 10, 1986. We hope that a 189(a) hearing will be held on this exemption request if you are seriously entertaining the exemption, since it would be construed as an amendment to the requirements for obtaining an operating license. Please advise us if you have a timetable for making this decision.
- 5.) Have you discovered whether the NRC Office of Investigations in Region II has ever completed its investigation regarding the whistleblowing activities of Ms. Miriello? If so, could you please send us a copy of any documents resulting from this investigation.

Thank you very much for your cooperation with these matters. We just want to know that all unanswered safety questions are resolved before any license is issued to CP&L for loading fuel at the Harris reactor. I hope you had a pleasant vacation.
