HIGHLIGHTS OF KEY ISSUES

1. Assessment of the Quality of Selected NRC Research Programs – FY 2017

The Committee completed its report on the quality assessment of NRC research projects on NUREG-2208, “Validation of Computational Fluid Dynamics Methods Using Prototypic Light

Water Reactor Spent Fuel Assemblies Thermal-Hydraulic Data” and NUREG/CR-7222, “Tsunami Hazard Assessment Based on Wave Generation, Propagation, and Inundation Modeling for the U.S. East Coast.”

Committee Action

The Committee issued a letter dated January 23, 2018, transmitting this report to the Director, Office of Nuclear Regulatory Research. The Committee found that:

- NUREG-2208 – this project was found to be satisfactory, a professional work that satisfies research objectives.
- NUREG/CR-7222 – this project was found to be satisfactory, a professional work that satisfies research objectives.
