This refers to your license amendment request submitted by Malgorzata Kouretas dated October 24, 2017. Please find enclosed Amendment No. 34 authorizing the radiological survey plan for Building 315. The plan titled, "Radiological Survey Plan for Structures at Picatinny Arsenal," dated September 21, 2017, along with the amendments as stated in the letter dated January 2, 2018, is accepted as well as the derived concentration guideline level of 2,240 dpm/100cm<sup>2</sup> beta gamma for this building.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(20).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. 
