Dear Mr. Stoddard:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2017-014) on May 10, 2017, to determine whether a former manager at Millstone deliberately failed to report for a random fitness-for-duty (FFD) test, and whether senior site management deliberately failed to take required follow-up actions. Based upon documentary and testimonial evidence developed during the OI investigation, the NRC did not substantiate that the former manager failed to report for a FFD test; as such, we also did not substantiate that site management knew of and failed to take required follow-up actions.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records.
