In accordance with 10CFR50.54, "Conditions of licenses," paragraph (p)(2), Exelon Generation Company, LLC (EGC) is submitting Revision 17 to the Clinton Power Station Security Plan. Changes to this document were implemented on December 15, 2017. In accordance with 10CFR50.54(p)(2), EGC is submitting these changes within 60 days of implementation.

The Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan have been revised to clarify what communications systems are being used to meet the Milestone 8 cybersecurity requirements.

EGC has concluded that the changes do not decrease the safeguards effectiveness of the Clinton Power Station Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.

Attachments 1 and 2 contain Safeguards Information. Therefore, EGC requests that this information be withheld from public disclosure in accordance with 10CFR2.390, "Public inspections, exemptions, requests for withholding," paragraph (d)(1), and 10CFR73.22, "Protection of Safeguards Information: Specific Requirements," paragraph (a)(1)(i).

There are no regulatory commitments contained in this letter.


