Enclosed is Amendment No. 36 to your NRC Materials License No. 24-17450-01 in accordance with your request dated October 26, 2017.

As requested, we have converted your license from a Type A broad scope to a Type B. Please note several of the changes to your license as part of this major revision. Specifically, Conditions 17 and 20 were added. Also, Condition 12 was amended to reflect the Type B designation. Lastly, several of the previous documents tied down in Condition 21 were removed since they have been superseded.



You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture.
