Dear Mr. Dougall:

Enclosed is Amendment No. 94 to your NRC Material License No. 21-01078-01 in accordance with your request.

We have deleted your iridium-192 authorization in Subitem Nos. 6. through 9 G, inclusive, as it appeared on Amendment No. 93. As a result, changes were made to the Subitem Numbers that formerly sequentially followed this authorization, in addition to Condition Nos. 10.A., 10.B., 14.D. and 14.E.

In the course of this review, I noticed that Subitem Nos. 6. through 9.F. does not authorize any specific radionuclide, as required by 10 CFR 35.49.

Within 30 days of the date of this letter (by February 1, 2018), please submit an amendment request specifying at least one radionuclide to be covered by this authorization, as well as the manufacturer's name and model of the device it is intended for. Information in NUREG 1556 Vol. 9, Rev. 2 may assist you in preparing your response.

If this timeframe cannot be met, please contact me to make alternative arrangements.



You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.
