This letter serves as notice that effective December 28, 2017, Eurofins Eaton Analytical, Inc. (the "Corporation"), a corporation incorporated under the law of the State of Delaware, was converted into Eurofins Eaton Analytical, LLC (the "LLC"), a limited liability company under the law of the State of Delaware. A copy of the certificate of conversion and the certificate of formation filed with the Delaware secretary of state are attached to this letter. As a result of this conversion, all of the rights, privileges and powers originally held by the Corporation, and all property owned by, all debts due to, and all other things and causes of action belonging to the Corporation, remain vested in the LLC.

Subsequent to and independent from the aforesaid conversion, the ownership of the LLC changed. As of December 29, 2017, the LLC is no longer owned by Eurofins Environmental Testing US Holdings, Inc., a Delaware corporation, but is now an independent subsidiary of Eurofins Lancaster Laboratories, Inc., a Minnesota corporation.
