Hannibal Clinic Operations, LLC would like to transfer control of its Byproduct Materials License, Number 24-32619-01, to Blessing Health System. In accordance with Appendix G of NUREG 1556, Volume 9, Revision 2, please accept the following description of the transfer of control:

1. Hannibal Clinic Operations L.L.C. has transferred all stocks and assets to Blessing Heath System. The facility name, Hannibal Clinic Operations L.L.C, will remain the same. Melissa Best will remain as lead tech and contact person, on-site at 572-231-3289
2. There will be no changes in personnel or duties in regards to the transfer of control. The Radiation Safety Officer and Authorized Users will remain the same.
3. There will be no changes in the organization, location, facilities, equipment, or procedures that relate to the licensed program.
4. The surveillance program that is currently in place complies with USNRC regulations. Daily radiation surveys, weekly radioactive contamination surveys, quarterly sealed source inventory and leak tests, and personal dosimetry are currently performed. The transfer of control will not alter the current surveillance program.
5. We confirm that all records concerning the safe and effective decommissioning of the facility will be maintained at the current address of use listed on License Number 24-32619-01. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. If the License is terminated in the future, the records will be transferred to the USNRC, as appropriate.
6. We confirm that the transferee will abide by all constraints, conditions, requirements, and commitments of the transferor.
