By letter dated May 26, 1987, TVA submitted justification for the proposed use of artificial ground motion time history as an alternate seismic input for seismic system analyses. The staff has completed its review of the subject submittal and determined that the use of artificial ground motion time histories is appropriate for the purpose of seismic re-analysis. However, the staff finds that TVA has not completely satisfied the SRP 3.7.1 enveloping requirements in that the response spectra obtained from the generated artificial time histories did not envelop the design ground response spectra for all damping values to be used in the analyses of structures, systems and components. This position is consistent with NRC practice applied to other licensing and operating reactor reviews as well as the position taken as a part of the SEP plant reviews.




