I am responding to your letter dated October 4, 2017, which requested that the U.S. Nuclear Regulatory Commission (NRC) approve a new truck route designated as No. 256 for transporting spent nuclear fuel from National Institute of Standards and Technology to the Savanna River Site, including the primary route, 1st alternate and 2nd alternate routes.

The NRC has reviewed your application and concluded that the information you provided on October 4, 2017, satisfies the requirements of Title 10 of the *Code of Federal Regulations* Section 73.37. This letter constitutes approval. The approved route is designated as Truck Route No. 256, and will expire February 26, 2023. The NRC expects your periodic review and update of the emergency phone numbers associated with this route. Changes to emergency contact numbers do not qualify as a route deviation or change.
