BROWNS FERRY NUCLEAR PLANT (BFN) - TVA BFN TECHNICAL SPECIFICATION NO. 247 - UPGRADE TO FIRE PROTECTION TECHNICAL SPECIFICATION SECTIONS 3.11 AND 4.11

In accordance with the provisions of 10 CFR 50.4 and 50.90, we are submitting a request for an amendment to licenses DPR-33, DPR-52, and DPR-68 to change the BFN Technical Specifications for units 1, 2, and 3 (enclosure 1).

The proposed changes address updating and revising sections 3.11 and 4.11 of the current BFN Technical Specifications. This change is requested in order to align BFN activities to current industry fire protection practices and standards.

Description, reason for change, and justification in support of the proposed changes are enclosed (enclosure 2). A proposed determination of no significant hazards consideration is provided in enclosure 3.

By letter dated November 20, 1985, BFN submitted a proposed technical specification change (TS 215) for smoke detectors. The proposed change requested deletion of the requirements to check smoke detector sensitivity in accordance with the manufacturer's instructions.

By copy of this letter, we are withdrawing the proposed technical specification (TS 215) change. The proposed technical specifications contained in this submittal reflect current industry practices with regards to fire detection instrumentation.
