Curtiss-Wright Corporation ("Curtiss-Wright") hereby submits the attached Application for License and application fee of \$9,200.00 for the export of various components and spare parts to be installed into the proposed civil nuclear reactors Sanmen 3&4.

Curtiss-Wright has previously applied for an export license for major components to these same reactors (XR-177). XR-177 would normally also cover the minor components listed in this new license application, however the Chinese customer has indicated that they are not going to provide assurances for XR-177 in the near future and we need a license soon in order to meet our contractual obligations. For this reason, Curtiss-Wright respectfully requests expedited processing of this application to the extent that US governmental agencies have control.
