AMENDING EXEMPT DISTRIBUTION LICENSE 04-23968-01E**

Dear Mr. Motamed:

This letter refers to your letters dated December 15, 2017 and January 8, 2018, requesting a name change and adding additional distributing locations. In reviewing your response, we have determined additional information is required to complete our review. In order to continue our review, please address the issues listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) 32.14, "Certain items containing byproduct material; requirements for license to apply or initially transfer."

In order to change your license name, and add additional locations to your Exempt Distribution License 20-23904-01E, you need to provide a copy of your possession license issued by the State of California to reflect that you are authorized to use radioactive material in the locations requested, and your new name is on your possession license.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the NRC may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS). ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
