Subject: Change of Control Requirements IAW 10 CFR 30.34(b) for current and future acquisitions

Discussion: Discussed with the Corporate RSO of Terracon Consultants, Inc. (transferee) change of control requirements for NRC licensees. We discussed the importance of notifying the NRC prior to acquisition of companies possessing NRC licenses to allow the NRC time to analyze and give written approval for the transfer of control. The RSO committed to speak with his management to get them to provide sufficient prior notification to allow notification to the NRC of change of control actions.

We discussed the current change of control action and that he needs to re-submit the change of control checklist because item 6 has the transferee and transferor names reversed.

Action Required: The RSO will resubmit the corrected change of control checklist.
