NOTICE OF WITHDRAWAL OF APPLICATION FOR  
AMENDMENT TO FACILITY OPERATING LICENSE

The United States Nuclear Regulatory Commission (the Commission) has granted the request of Niagara Mohawk Power Corporation (the licensee) to withdraw its March 31, 1992, as supplemented May 13, 1992, application for proposed amendment to Facility Operating License No. DPR-63 for the Nine Mile Point Nuclear Station Unit No. 1, located in Oswego County, New York.

The proposed amendment would have revised Technical Specifications 3.1.1b(1) and 4.1.1b(1) to allow operation with control rod 22-31 potentially uncoupled for the remainder of cycle 10, which is currently scheduled to end in January 1993.

The Commission had previously issued a Notice of Consideration of Issuance of Amendment to Facility Operating License, Proposed No Significant Hazards Determination, and Opportunity for Hearing published in the FEDERAL REGISTER on April 15, 1992, (57 FR 13149). However, by letter dated July 7, 1992, the licensee withdrew the proposed change.

SUBJECT: NINE MILE POINT NUCLEAR STATION UNIT NO. 1 WITHDRAWAL OF AN  
AMENDMENT REQUEST (TAC NO. M83065)

By letter dated March 31, 1992, as supplemented May 13, 1992, you applied for an amendment to the Nine Mile Point Nuclear Station Unit No. 1 Operating License, No. DPR-63. The proposed change would have modified the facility technical specifications pertaining to operation for the remainder of cycle 10 with control rod 22-31 potentially uncompleted. Subsequently, by letter dated July 7, 1992, you withdrew the amendment request.
