Subject: Need for Submission of DFP Evaluation

Discussion: (1/22/2018; 08:10) I contacted Mr. Shaw to determine if a Decommissioning Funding Plan (DFP) Reevaluation was submitted to the NRC Region I office. Mr. Shaw stated that he had been working on the DFP intermittently; but, he had not submitted it. I informed him that the DFP was expected in December 2017. Mr. Shaw indicated that he believed that he had three years from the acceptance letter which gave him until March to submit the DFP. I informed Mr. Shaw that the regulations requires that the DFP reevaluation be submitted every three years and at the time of renewal of the license. Since a review of a submission may take a long time, the DFP reevaluation is only good for three years from the last time the DFP was amended. Mr. Davis stated that he would complete and submit the DFP reevaluation as soon possible.
